- d. Mentor other students, encouraging their growth in faith and leadership.
- e. Identify and train potential student leaders for future spiritual leadership roles.

# **Bylaws**

Section 3 – Participation

SA Senate meetings shall occur biweekly. Due to the time constraints this creates, the following procedures shall be taken:

- 1. Attendance of all participants, including senators, the exec vp, parliamentarian, and secretary, shall be taken. Any tardy arrivals or absences will be recorded. Being tardy three times will be marked as one absence.
- 2. A senator may have a constituent sit in their place for two meetings per semester after discussing each case with the Executive Vice President and/or the Parliamentarian at least twenty-four hours before any meeting. If a substitute is used more than once, the second and all subsequent times will result in an absence on the record for the senator. Substitution is not allowed in the last two meetings of the year, not including the end-of-year outing, or the stipend will be adjusted, per the judgment of the Executive Vice President and Parliamentarian.
- 3. Any absences in excess of two per semester will be referred to the SA Executive Vice-President for subsequent penalties.

# **Updated Quote**

The bike racks got cheaper! The cost for buying and shipping 6 units is now \$2,988.00 - \$498 per unit instead of \$503 per unit and Shipping is \$483.09 instead of \$477.51

The higher final price does not affect Senate as it just includes the anchoring kits, which Senate does not pay for:

\$3,783.09 with anchoring kits vs \$3,495.51 without anchoring kits
